Dear Mr. Lowe:

On May 2, 2016, First Point Power, LLC (First Point Power), a competitive electric power supplier currently authorized to provide service in the franchise areas of Liberty Utilities, Public Service Company of New Hampshire, d/b/a Eversource Energy, and Unitil Energy Systems, filed a request to expand its service area to include the franchise area of New Hampshire Electric Cooperative, Inc. (NHEC). With its filing, First Point Power included a copy of a certificate demonstrating it had completed electronic data interchange testing with NHEC.

Staff reviewed the filing and recommended the Commission approve the request, in a memorandum filed on May 3, 2016. The Commission has reviewed First Point Power's filing and Staff's recommendation, and has approved First Point Power's request. Accordingly, First Point Power is authorized to expand its service area to include the franchise area of NHEC, effective as of the date of this letter.
