Overview of Relevant NEER Subsidiaries that participate in the New England Energy Markets:

NEER, a Delaware limited liability company, through its affiliates, is a leading producer of clean and renewable energy in North America. Through its affiliates, NEER owns and operates a diverse portfolio of power generation resources across the United States and Canada that includes wind, natural gas, nuclear, solar, and oil. NEER is the largest generator of wind and solar power in North America, and NEER's generation fleet has a total generating capacity of 19,578 MW as of January 1, 2015. In New England, NEER, through its affiliates, operates power generation facilities in Massachusetts, Maine, and New Hampshire. NEER affiliates are also among the nation's leading natural gas marketers, responsible for fuel management for all of NEER's generation fleet and for providing a range of electricity and gas commodity products and marketing and trading services to owners of electric generation facilities, electric and gas utilities, municipalities, cooperatives, and other load-serving entities, as well as gas marketers.

NextEra Energy Seabrook, LLC ("Seabrook")

NEER subsidiary Seabrook owns 88.23% of and operates Seabrook Station, a nuclear power plant located in Seabrook, New Hampshire. Seabrook Station has a generating capacity of 1,247 MW, making it one of the largest power generators in the ISO-NE region. Seabrook Station has an excellent operating history and has provided power reliably to New England customers, including those in New Hampshire, since the plant first began full power operations in 1990. Seabrook Station has applied to the U.S. Nuclear Regulatory Commission to extend the plant's operating license to March, 2050, thereby allowing Seabrook Station to continue to provide reliable service for many decades to come. As a baseload generator, Seabrook Station

relies upon a market to set prices that are premised on competition, without subsidization of certain generators based on fuel source and access to a specific pipeline.

ESI Northeast Energy LP, LLC and ESI Northeast Energy GP, Inc. (together “Northeast Energy”)

Northeast Energy, through subsidiaries, owns and operates the dual-fuel capable, 300 MW combined-cycle power plant located at the Bellingham Energy Center in Bellingham, Massachusetts through a joint venture with Engie, S.A. The Bellingham Energy Center takes gas from the Algonquin Gas Transmission pipeline operated by Spectra Energy Corporation.

NextEra Energy Power Marketing, LLC (“NEPM”)

NEPM is a nation-leading electricity and natural gas marketer with a power and gas trading business that provides commodities-related products to its customers. NEPM buys and sells wholesale energy commodities, such as electricity, natural gas, and oil. NEPM sells the output from NEER’s generation assets that is not under long-term contracts and procures the fossil fuels used by NEER’s generation fleet. NEPM is responsible for managing the risk associated with fluctuating commodity prices and for optimizing the value of NEER’s power generation and gas infrastructure assets. NEPM’s customers also include owners of electric generation facilities, electric and gas utilities, municipalities, cooperatives, and other load-serving entities. NEPM operates in New England’s markets where, among other things, NEPM buys and sells natural gas at wholesale and acquires capacity on all the gas pipelines in the region, including the Algonquin Pipeline.

NEER’s Maine Generators

FPL Energy Cape, LLC owns and operates the Cape Energy Station, a 273 MW oil-fired generation facility located in South Portland, Maine. FPL Energy Wyman, LLC owns and operates Units 1-3 of the W.F. Wyman Station and FPL Energy Wyman IV owns a majority

interest in and operates Unit 4 of the W.F. Wyman Station. The W.F. Wyman Station is a 620 MW oil-burning generator in Yarmouth, Maine.
