ASSENTED-TO NOTICE OF AUTOMATIC EXTENSION OF TIME
PURSUANT TO SUPREME COURT RULE 21(6-A)

Petitioner Public Service Company of New Hampshire d/b/a Eversource Energy (“Eversource”), for itself and for Petitioner Algonquin Gas Transmission, LLC (“Algonquin”), and with the assent of all counsel of record, requests an extension of time to file their briefs pursuant to Supreme Court Rule 21(6-A). In support of this Notice, Eversource and Algonquin state as follows:

1. The briefs of the Petitioners, Eversource and Algonquin, are currently due on May 15, 2017.
2. Petitioners respectfully request that they be permitted a fifteen-day extension to May 30, 2017 to file their briefs.
3. Eversource sought the assent of all counsel of record for this extension both for Eversource and for Algonquin. All counsel have indicated their assent to this request.
4. This is the first request for an extension of time in this appeal.

WHEREFORE, Petitioners respectfully request that this Honorable Court enter an Order:

(A) Enlarging the time within which Eversource and Algonquin may file their briefs by 15 days to May 30, 2017;

(B) Enlarging the time for filing of opposing briefs by 15 days to June 29, 2017; and

- (C) Enlarging the time for Eversource and Algonquin to file their reply briefs to July 19, 2017; and
- (d) Granting any other and further relief as may be just and appropriate.




