
The Department of Public Utilities ("Department") has reviewed the application of Anderson Energy Solutions, LLC ("Anderson Energy" or "Company") for an Electricity Broker license in the Commonwealth of Massachusetts, and is pleased to inform you that the Department has approved the application. Anderson Energy's license number is **EB-354**.

Consistent with the information provided in Anderson Energy's application, the activities the Company is licensed to provide are limited to electricity broker services to commercial and industrial customers. If, at a later date, the Company seeks to provide electricity broker services to residential customers, it must first seek and obtain Department approval when renewing its license.


As a condition of maintaining this license, Anderson Energy must comply with all relevant requirements of G.L. c. 164 and the regulations promulgated thereunder, including 220 C.M.R. §§ 11.00, 12.00 *et seq.* In addition, within 30 days of any material change in the information required by 220 C.M.R. § 11.05(2), the Company must file updated information

with the Department. If Anderson Energy requests a renewal of its license next year, please submit the renewal application no later than **February 1, 2017**.


