Dear Ms. Howland:

On April 29, 2016, Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty Utilities filed a petition to implement new permanent distribution rates, to set temporary electric distribution rates, and to amend various tariffs, all for effect July 1, 2016. The Commission issued Order No. 25,899 (May 10, 2016) which suspended the tariffs and scheduled a pre-hearing conference for May 23, 2016.

The Office of Consumer Advocate (OCA) filed a letter on May 2, 2016 indicating its participation in the docket. On May 20, 2016, the City of Lebanon, NH filed a petition to intervene, which the Commission granted at the pre-hearing conference.

Following the May 23rd prehearing conference, the parties met in a technical session to establish a procedural schedule for both the temporary rate and the permanent rate segments of this proceeding.

The Parties agree to the following schedule for the temporary rate segment:
