RE: DT 16-534: Request for Adoption of Interconnection Agreement

Dear Mr. Meehan:

On May 6th, 2016, Northern New England Telephone Operations LLC (FairPoint) filed an Interconnection Agreement pursuant to 47 U.S.C. §252(e) with TDS MetroCom, LLC (TDS MetroCom). TDS MetroCom elected to adopt the terms of the Interconnection Agreement between FairPoint predecessor Verizon New England d/b/a Verizon New Hampshire and YMAX Communications Corp. pursuant to 47 U.S.C. §252(i).

The Commission elects to take no action on this petition. Accordingly, pursuant to 47 U.S.C. §252(e)(4), the adoption of the Interconnection Agreement will take effect by operation of law 90 days after its filing, on August 4, 2016. Notwithstanding the foregoing, any clause in the Agreement found to be in violation of any Commission order is null and void.

The Commission has updated its records to include the adoption of this agreement. Please refer to Docket No. 16-534 in any future correspondence.
