Customer Accounts to Another Licensed Electric Supplier

Dear Ms. Howland:

As discussed in recent emails with staff members of the Public Utilities Commission ("PUC"), South Jersey Energy Company ("SJE") hereby revises its earlier May 6, 2019 Rule PUC 2004.13(c) notice letter to reflect that, at staff's request, SJE has delayed its planned transfer of electricity customer accounts in New Hampshire to First Point Power, LCC ("First Point Power") by not less than one month (i.e., to not earlier than July 1, 2019, and effective at the first meter read for each customer in month of July) and has re-issued its customer notice letter to ensure that customers would have at least thirty (30) days' notice of the planned change to First Point Power. A copy of the revised PUC 2004.13(a) customer notice is attached hereto as an exhibit to this letter. As previously stated, please note that SJE plans to withdraw its New Hampshire license and cancel its bond once all customers are transferred to First Point Power or other service options.

IMPORTANT NOTICE - Assignment of Agreement to First Point Power, LLC

Dear Customer:

It has been our privilege to serve your electricity service needs, together with our billing agent, Halifax American Energy Company ("Halifax"). However, South Jersey Energy has decided to exit the retail energy business. Pursuant to the provisions of your Agreement with South Jersey Energy, your Agreement may be assigned. South Jersey Energy has selected First Point Power, LLC ("First Point Power"), a reputable and licensed energy provider, to assume your existing Agreement.

Upon completion of this planned transaction, South Jersey Energy will discontinue providing electricity service and First Point Power will become your electricity supplier, effective the first available meter read date on or after **July 1, 2019**. First Point Power will administer your energy needs under the same terms and conditions in your current Agreement, including pricing structure and duration. Based in Rhode Island, First Point Power is one of the largest and most experienced suppliers in New England. You will receive the same high-quality electricity service you have come to expect from South Jersey Energy and Halifax.

You will not be charged for this change of electricity provider. No action is required by you, and there will be no interruption in your electricity service. South Jersey Energy will work closely with First Point Power to transfer your account. Both parties are communicating this assignment to regulatory agencies and your local distribution utility.
