Dear Mr. Lyons:

On May 17, 2016, BKE Mechanical, Inc. (BKE Mechanical) submitted an application to the Commission to register as a provider of electric aggregation service. Commission Staff has reviewed the application and determined it is incomplete and therefore does not comply with the requirements of N.H. Code Admin. Rules Puc 2003. In particular, Staff identified the following requirement that has not been met and the related item which is missing from the application:

1) The application lists a non-permitted trade name, BKE Energy, Inc. as its trade name.

Puc 2006.02 Form for Initial and Renewal Registration of Aggregators. (5) A copy of the applicant's authorization to do business in New Hampshire from the secretary of state, if anything other than an individual.

Regarding item #1, Staff noted that the N.H. Secretary of State website does list BKE Energy as a registered trade name. To correct this, either:

- a) File a revised application that lists BKE Energy as the trade name, or
- b) File a statement that the correct trade name is BKE Energy, and not BKE Energy, Inc. as listed on the initially filed application; and

Provide a recent printout of the applicant's trade name registration on the N.H. Secretary of State website, with the status shown as "Good Standing" or words of similar import, or a certificate from the Secretary of State
