PURSUANT TO RSA 362-A:9, XVI - Electric Distribution Utilities Development of New Alternative Net Metering Tariffs and/or Other Regulatory Mechanisms and Tariffs for Customer-Generators

Solar Endeavors, LLC Petition to Intervene

Now comes Solar Endeavors, LLC submitting this Petition to Intervene in reference to the above docket, noting such:

Solar Endeavors, LLC, with office in Rye, NH, is a growing solar company serving NH, Northern Massachusetts and Southern Maine. Our sole business is as a full-service, end-to-end design and installation company for grid-tied solar photovoltaic renewable energy systems. With a full-time and contract staff of 15-20, almost all in New Hampshire, our primary focus is residential and commercial (typically under 100KW) systems of which we have installed 30 in the past year with another 42 currently in the pipeline.

Solar Endeavors, LLC has a fully-vested direct, economic interest in the processes involved in developing and implementing the new alternative net metering tariffs. We represent ourselves, NH residents and smaller commercial entities, including farms and other agriculturally-focused companies, who have a strong desire to move forward with renewable projects mindful of the declarations pursuant to HB1116 noting: "the continuance of reasonable opportunities for electric customers to invest in and interconnect customer generator facilities and receive fair compensation for such locally produced power while ensuring costs and benefits are fairly and transparently allocated among all customers, and the promotion of a balanced energy policy that supports economic growth and energy diversity, independence, reliability, efficiency, regulatory predictability, environmental benefits, a fair allocation of costs and benefits, and a modem and flexible electric grid that provides benefits for all ratepayers."

Solar Endeavors, LLC was actively involved in the legislative process for both SB333 and the ultimate passage of HB1116, including written and verbal testimony at both the New Hampshire House and Senate level, which mandated said current docket.

Solar Endeavors, LLC's intervention will not disrupt the orderly conduct of this proceeding and is solely in the interest of justice. As such, Solar Endeavors, LLC requests with due respect, to be granted full intervenor status in these proceedings and granted such other relief as the Commission deems just and equitable.
