Request to Withdraw Registration as a Competitive Electric Power Supplier

Dear Mr. Brett:

On April 18, 2019, TransCanada Power Marketing Ltd. (TransCanada) filed with the Commission a request to voluntarily withdraw its registration as a competitive electric power supplier (CEPS). In its request, TransCanada noted that, on March 1, 2018, it had divested its retail power marketing business to EDF Energy Services. In accordance with N.H. Code Admin. Rules Puc 2004.13, all existing customers at that time were provided notice of their option of assigning their retail contracts to EDF Energy Services at the same price and terms or remaining with TransCanada until their current contract terms ended. On December 10, 2018, the final remaining TransCanada customer contract term was completed. There have been no customers served by TransCanada in New Hampshire for the past 120 days, according to the filing.

Commission Staff filed a memorandum on May 1, 2019, in which it confirmed its review of the application and recommended that TransCanada's CEPS registration be withdrawn and terminated, pursuant to N.H. Code Admin. Rules Puc 2003.08. Staff confirmed that the Commission's Consumer Services Division has no pending customer complaints against TransCanada.

Accordingly, TransCanada's CEPS registration is deemed withdrawn and terminated, and its related financial security obligations may be released, effective as of the date of this letter.
