Dear Mr. Holmes:

On July 26, 2016, Front Line Power Solutions, LLC (Front Line) filed an application to renew its registration as a provider of natural gas aggregation service. On September 16, Staff filed a deficiency letter requesting more information. On October 13, 2016, Front Line provided the additional information. On November 7, 2016, Front Line requested a waiver of Puc 3003.05(a) which requires a renewal application to be filed 60 days before the registration expiry date on August 13, 2016. Front Line's renewal application was due on or before June 15, 2016. Front Line explained that the delay was due to an administrative mistake and it already took remedial action.

On November 15, 2016, Staff filed a recommendation to grant the waiver and approve the renewal application. Consistent with Staff recommendation the Commission grants the waiver request for this time only. The Commission also approves your renewal application effective from August 14, 2016. The registration is for a term of 5 years and expires at the end of business on August 13, 2021. Pursuant to N.H. Code Admin. Rules Puc 3003.02(a), you must submit your next renewal application at least 60 days prior to the expiration of the registration approved here, on or before June 15, 2021.

Please be aware that registered providers of natural gas aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 3000 - Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at: http://www.puc.state.nh.us/Regulatory/Rules/PUC3000.pdf.

Please note that, effective as of July 1, 2014, each registered natural gas aggregator is subject to an annual assessment of \$2,000, unless it demonstrates that its gross revenue in New Hampshire during the preceding fiscal year (from July 1 through

June 30) was less than \$10,000, pursuant to RSA 363-A:2, III and 5.
