On November 8, 2017, Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource) filed a Motion for Confidential Treatment of certain information contained within discovery in the above referenced proceeding. On November 20, 2017, the Office of Consumer Advocate (OCA) with the assent of Staff, filed an Objection to Eversource's motion. On November 21, 2017, Staff and the OCA filed a request to suspend the procedural schedule to allow the Commission time to consider the Motion and Objection, and for Staff and the OCA to determine whether additional discovery is needed.
