Request for Suspension of Procedural Schedule

Dear Ms. Howland:

Pursuant to the procedural schedule in the above-captioned docket, Staff and the Office of Consumer Advocate (OCA) issued two sets of discovery on Eversource Energy. In connection with the discovery requests, Eversource filed a Motion for Confidential Treatment for certain information on November 8, 2017. The OCA, with the assent of Staff, timely filed an Objection to Eversource's motion yesterday, November 20, 2017.

The procedural schedule provides that testimony be filed by Staff and the OCA today, November 21, 2017. Staff respectfully requests that the Commission suspend the procedural schedule to allow the Commission time to consider the Motion and Objection, and for Staff and the OCA to determine whether additional discovery is needed. Staff understands that the OCA made a similar request in the Objection it filed yesterday. Staff did not seek the position of Eversource due to the urgency in making this request.
