On November 13, 2017, Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource) filed an updated petition and testimony in the above referenced matter. According to the filing, as a result of entering into purchase and sale agreements for the divestiture of all of its remaining assets, Eversource is able to better quantify the amount of required securitization financing. On November 21, 2017, Staff notified the Commission that a stipulation in principle among Eversource, the Office of the Consumer Advocate and Staff had been reached and that the updated petition should be approved as filed. Accordingly, a hearing on the merits has been scheduled for December 6, 2017 at 9:00 a.m.
