**Joint Approval for Acquisition  
of Aquarion Water Company of New Hampshire, Inc. by  
Eversource Energy**

**ORDER OF NOTICE**

On June 29, 2017, Eversource Energy and Aquarion Water Company of New Hampshire, Inc. (Eversource and Aquarion, respectively, or collectively, the Companies) filed a joint petition pursuant to RSA 369:8 II and RSA 374:33 to approve the indirect acquisition of Aquarion by Eversource. On June 1, 2017, Eversource, as purchaser, and Macquarie Utilities Holdings, GP as seller, entered into a purchase and sale agreement by which Eversource will acquire all of the issued and outstanding stock of Macquarie Utilities, Inc. (MUI). The transaction will result in Eversource having ownership and control of MUI and its subsidiaries Aquarion Company, Aquarion Water Company and Aquarion. Aquarion is a New Hampshire corporation and public utility as defined by RSA 362:2. Aquarion serves approximately 9,500 customers in the Towns of Hampton, North Hampton and Rye, New Hampshire. Aquarion Company is a Delaware corporation and the parent company of Aquarion Water Company. Aquarion Water Company is a Connecticut corporation and the parent company of Aquarion.

Upon the satisfaction of all conditions for the closing, including approval by the Commission, Eversource will be the holding company and sole stockholder of MUI and MUI will be a wholly-owned subsidiary of Eversource. MUI will be renamed Eversource Aquarion

Holdings, Inc. and remain the holding company of the Aquarion subsidiaries. There will be no change in Aquarion's corporate structure. The petition and subsequent docket filings, other than any information for which confidential treatment is requested of or granted by the Commission, will be posted to the Commission's website at

The filing raises, inter alia, issues related to RSA 369:8, II(b)(1) which provides that Commission approval for the acquisition shall not be required if the Companies demonstrate "that the transaction will not adversely affect rates, terms, service, or operation of the public utility within this state" and RSA 374:33 which provides that no public utility or utility holding company shall directly or indirectly acquire more than 10 percent, or more of the stocks or bonds of any other public utility or public utility holding company doing business in this state "unless the commission finds that such acquisition is lawful, proper and in the public interest." Each party has the right to have an attorney represent the party at the party's own expense.

**Based upon the foregoing, it is hereby**

**ORDERED**, that a Prehearing Conference, pursuant to N.H. Code Admin. Rules Puc 203.15, be held before the Commission located at 21 S. Fruit St., Suite 10, Concord, New Hampshire on August 17, 2017 at 1:30 p.m., at which each party will provide a preliminary statement of its position with regard to the petition and any of the issues set forth in N.H. Code Admin. Rules Puc 203.15; and it is


**FURTHER ORDERED**, that, immediately following the Prehearing Conference, Eversource and Aquarion, the Staff of the Commission and any Intervenors hold a Technical Session to review the petition; and it is

**FURTHER ORDERED**, that pursuant to N.H. Code Admin. Rules Puc 203.12, Eversource and Aquarion shall notify all persons desiring to be heard at this hearing by publishing a copy of this Order of Notice no later than July 27, 2017, in a newspaper with general circulation in those portions of the state in which operations are conducted, and by serving a copy of this Order of Notice upon the Town Clerk of each of the Towns of Hampton, North Hampton and Rye by first-class mail, postage prepaid, with publication to be documented by affidavit filed with the Commission on or before August 15, 2017; and it is

**FURTHER ORDERED**, that consistent with N.H. Code Admin. Rules Puc 203.17 and Puc 203.02, any party seeking to intervene in the proceeding shall submit to the Commission seven copies of a Petition to Intervene with copies sent to Eversource and Aquarion and the Office of the Consumer Advocate on or before August 15, 2017, such Petition stating the facts demonstrating how its rights, duties, privileges, immunities or other substantial interest may be affected by the proceeding, as required by N.H. Code Admin. Rule Puc 203.17; and it is

**FURTHER ORDERED**, that any party objecting to a Petition to Intervene make said Objection on or before August 17, 2017.
