On June 20, 2018, PEU filed an assented to motion to amend the approved procedural schedule in this proceeding to move the filing date of a Settlement Agreement among the parties from June 28, 2018 to July 17, 2018. The Commission approved PEU's motion by a Secretarial Letter issued on June 22, 2018. Staff is requesting that the approved deadline for filing a Settlement Agreement in this case be extended to July 18, 2018, in order to provide the parties with one additional day in which to review the terms of the finalized document.
