Dear Ms. Howland:

Pursuant to Order No. 26,179 (October 4, 2018) in the above-captioned proceeding, Pennichuck East Utility, Inc. ("PEU" or the "Company") seeks recovery of \$53,864.82 in rate case expenses. As set forth in the summary of rate case expenses, <u>Attachment A</u>, the Company seeks recovery for legal services, filing preparation services, publication notice, customer notice mailing and stenographic services, which are allowable expenses consistent with the Commission's rule, Puc 1906.01. If recovered over 12 months, the monthly rate case expense charge per customer would be \$0.559 per month. PEU also provides, as <u>Attachment B</u>, documentation of its rate case expenses, consistent with the Commission's rule, Puc 1905.03 (a) through (d).

On April 6, 2017, PEU filed a request for a waiver regarding procurement of legal services through a competitive bid process. *See* DW 17-059. On April 28, 2017, the Commission issued Order No. 26,013 granting the request "for the good cause shown and reasons stated in their motion...." Order at p. 3. In light of the waiver granted by the Commission, this filing does not include copies of the Company's written procurement policy.
