On September 5, 2017, NORESCO, LLC submitted an application with the Commission to register as a provider of electric aggregation service. Staff reviewed the application and determined that it is complete.

The Commission approves your application effective as of September 6, 2017. The registration is for a term of two years and expires at the end of business on September 6, 2019. Pursuant to N.H. Code Admin. Rules Puc 2003.05(a), you must submit a renewal application at least 60 days prior to the expiration of the registration approved here, on or before July 8, 2019.

Please be aware that registered providers of electric aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 2000 – Competitive Electric Power Supplier and Aggregator Rules. These rules are available at:

http://www.puc.nh.gov/Regulatory/Rules/PUC2000.pdf. Please also be aware that revised Puc 2000 rules, which were adopted on August 25, 2017, and become effective on November 1, 2017, contain certain requirements that are different from those in the currently effective rules. The revised rules can be accessed at: Puc 2000 Rules Amendments Effective 11-1-17.

Please also note that, effective as of July 1, 2014, each registered electric load aggregator is subject to an annual assessment of \$2,000, unless it demonstrates that its gross revenue in New Hampshire during the preceding fiscal year (from July 1 through June 30) was less than \$10,000, pursuant to RSA 363-A:2, III and 5.
