Dear Director Howland,

Northern Utilities, Inc. ("Northern" or the "Company") hereby submits an original and six (6) copies of revised red-lined tariff pages pertaining to its 2017 / 2018 Annual Cost of Gas ("COG") Adjustment filing submitted on September 18, 2017 ("Initial Filing"). The Company submits these revised re-lined tariff pages to correct certain inconsistencies or errors identified on the record at the October 18, 2017 Hearing in the above-referenced docket.

The revised red-lined Tariff Sheets are:

Supplement No. 2, Original Page 3 (Rate summary),
Supplement No. 2, Original Page 4 (Rate Summary),
Supplement No. 2, Original Page 5 (Rate Summary),
Supplement No. 2, Original Page 6 (Rate Summary),
Nineteenth Revised Page 43 (COG), and
Alternate Fourth Revised Page 171 (Appendix D).

Red-lined Supplement No. 2, Original Pages 3, 4, 5 and 6 are now properly labeled as Commercial and Industrial ("C&I") rates. Red-lined Nineteenth Revised Page 43 (COG) now lists the correct proposed C&I rates. Lastly, red-lined Alternate Fourth Revised Page 171 (Appendix D) now shows the Company's proposed new tariff language redlined against the currently effective tariff page. As explained at the Hearing, the Company had inadvertently created a red-lined Alternate Fourth Revised Page 171 using an incorrect version of the existing tariff page.

Please note that the clean versions of these red-lined tariff pages required no corrections and these revisions have no impact on the proposed COG rates included in Northern's Initial Filing.


