Dear Ms. Howland:

As a result of discussions among the parties prior to this afternoon's hearing, the parties have agreed on a modification to the settlement on temporary rates filed in this docket on May 30, 2018 (Settlement). The following parties have agreed to amend the Settlement by making the effective date for temporary rates May 1, 2018, Omni Mount Washington, Abenaki Water Company, Inc., the Office of Consumer Advocate, and Commission Staff. The additional parties, Bretton Woods Property Owners Association and Forest Cottages Association, did not oppose the modification as to the effective date. All other terms of the Settlement remain as originally filed.

In exchange for moving the effective date for temporary rates from February 1, 2018, to May 1, 2018, Omni agreed to withdraw its pending motion for rehearing of Commission Order No. 26,157 (July 13, 2018).
