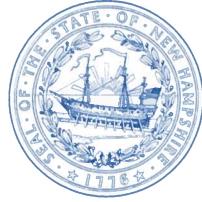

Technical Session	02/21/18 at 10 AM
Responses to Technical Session Inquiries	03/02/18
File testimony or settlement agreement	03/15/18
Hearing on the merits	03/29/18 at 10 AM

Staff and the parties agree that if testimony is filed on March 15, then Staff and the parties are likely to ask for a postponement of the March 29 hearing and a revised schedule to provide opportunities for discovery on that testimony. However, it is anticipated that a settlement agreement will be filed on March 15.
