On March 20, 2018, Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty Utilities (Liberty) filed a request to extend the deadline for Liberty to respond to supplemental data requests asked at the March 14 technical session from March 21 to March 23, 2018. Staff and the parties have assented to the request. The Office of Consumer Advocate did not respond.
