Petition to Approve Firm Supply, Transportation Agreements and the Granite Bridge Project

PETITION TO INTERVENE OF MARK VALLONE

Pursuant to the New Hampshire Public Utilities Commission ("Commission")'s Order of Notice dated February 8, 2018 ("Order") issued in the above-captioned matter, N.H. Code Admin. Rules Puc 203.17 and RSAS 541-A:32, I, Mark Vallone, hereby respectfully petition to be allowed to intervene in this proceeding as a party, with all rights as such to the full extent allowed by law, on grounds as follows:

- I am a New Hampshire citizen residing at 252 Blake Road, Epping, New Hampshire 03042.
- 2. I am a retired, life-long resident of Epping, former Principal of the Epping Elementary School, current member of the Epping Zoning Board of Adjustment, have spent decades working with generations of Epping citizens as a coach, teacher and community volunteer, and am otherwise very active in, and concerned with, Epping town affairs.
- 3. I attended and spoke during the public comment of the March 9, 2018 prehearing conference held in this matter, at which I discussed my concerns with the Granite Bridge Project which is the subject of this proceeding, and especially its proposed liquid natural gas (LNG) facility to be located in Epping, which would include a 170 feet high, 200 feet in diameter storage tank capable of holding 2 billion cubic feet of fracked liquid natural gas. As I commented, my concerns include a history of Epping being targeted as a proposed site for risky environmental "projects," including the Keefe Environment Services chemical waste treatment facility, which was

pitched to Epping as a bonanza in the late 1970s but is now only remembered as the current

superfund site. I also expressed concerns with the economics of the project, which had been debated

before the Epping Planning Board on March 8, 2018, the night prior to the prehearing conference.

4. Unfortunately, the Epping Planning Board meeting was held the day after the

March 7, 2018 deadline for filing petitions to intervene that is provided for by the Order, so I am

not filing this petition by that deadline. However, when I raised this at the prehearing

conference, Chairman Bailey responded that I should file this petition, anyway, and I am

submitting it as soon as possible accordingly, given my other obligations and the inclement

weather following the prehearing conference.

WHEREFORE, I respectfully request that the Commission:

A. Grant this petition and allow me to intervene in this proceeding as a party,

with all rights as such to the full extent allowed by law; or

B. Schedule a hearing on this matter; and

C. Grant such other and further relief as is just, lawful and otherwise appropriate.
