In Case No. 2019-0195, Appeal of Springfield Power, LLC & a., the clerk of court on April 18, 2019, issued the following order:

Notice of Docketing and Mandatory E-Filing

On April 4, 2019, Springfield Power, LLC, DG Whitefield, LLC, Bridgewater Power Company, L.P., Pinetree Power Tamworth, LLC, and Pinetree Power, LLC, filed a Rule 10 appeal document, which has been docketed in this court as case number 2019-0195. Because the case was initiated after the date of electronic filing (e-filing) implementation in this court, the case is governed by the amendments to the Supreme Court Rules and the 2018 Supplemental Rules of the Supreme Court of New Hampshire for Electronic Filing. These rules, which the court adopted on March 29, 2018, and made effective on August 6, 2018, are available for review on the Electronic Services page of the New Hampshire Judicial Branch website: <https://www.courts.state.nh.us/nh-e-court-project/supreme.htm>.

The rules require that attorneys submit all documents to the court through the court's electronic filing system, with the exception of case-initiating documents and certain other documents listed in 2018 Supplemental Rule 6. Parties representing themselves and nonlawyer representatives are required to submit all documents to the court conventionally, i.e., they must file paper documents. Electronic filing for self-represented parties and nonlawyer representatives is expected to be implemented during 2019.

Any attorney who intends to participate in this case or to remain on the service and distribution list should register with the Supreme Court e-filing system on the judicial branch website. The address for the Supreme Court e-filing system is <https://ctefile.nhecourt.us/login>. Prior to registering, it is recommended that attorneys review the Quick Guide – Registering as an E-Filer, which is available on the Electronic Services page. **Attorneys should register on or before April 29, 2019, if they have not done so already.** Registration is mandatory for attorneys who intend to participate in this case or to remain on the service and distribution list. Attorneys who do not intend to participate in this case or to remain on the service and distribution list should file a withdrawal as counsel on or before April 29, 2019.

After successfully registering, attorneys will receive through the e-filing system orders and notices issued by the court and filings submitted by other

registered attorneys. Attorneys electronically filing a document with the court are not required to submit copies. They must, however, serve self-represented parties and nonlawyer representatives conventionally by mailing or delivering a paper copy of the filing to self-represented parties and nonlawyer representatives.

Until electronic filing is implemented for self-represented parties and nonlawyer representatives and an order is issued implementing it in this case, self-represented parties and nonlawyer representatives must submit a filing to the court conventionally and mail or deliver a copy of the filing to all other parties. The court will send orders and notices to self-represented parties and nonlawyer representatives by mail at the addresses they have provided to the court. Self-represented parties and nonlawyer representatives will be served conventionally with filings by other parties.
