Dear Ms. Singer:

On January 4, 2019, Nordic Energy Services, LLC (Nordic) filed a request to withdraw its registration as a competitive electric power supplier (CEPS) and requested waivers of Puc 2004.15(a)(1) and 2004.15(c)(1), which require, for approval of voluntary discontinuance of service by a CEPS, that the CEPS provide a minimum 60-day notice to any affected utility and to the Commission of the date it intends to stop selling electricity, and that the Commission suspend the CEPS's registration for 120 days from the date the CEPS either notifies the Commission that it has no customers or ceases to provide service to all customers, respectively.

Commission Staff (Staff) filed a memorandum on January 10, 2019, in which it recommended that waivers of Puc 2004.15(a)(1) and (c)(1) be granted and that Nordic's CEPS registration be withdrawn and terminated. Staff stated that the Commission's Consumer Services Division has received no complaints from customers regarding Nordic.

The Commission has reviewed the request for withdrawal of Nordic's CEPS registration, and related rules waivers, and Staff's recommendation. The Commission has granted the waivers, having found waiver to be in the public interest under Puc 201.05, and the request to withdraw and terminate Nordic's registration as a CEPS.

Accordingly, waivers of Puc 2004.15(a)(1) and (c)(1) have been granted and Nordic's request for the withdrawal of its registration as a CEPS is approved, effective as of the date of this letter.
