2018 Petition for Qualified Capital Project Adjustment Charge (QCPAC)
Amendment to Procedural Schedule

To the Parties:

On July 12, 2018, the Commission Staff (Staff) filed a request to amend the procedural schedule in the above referenced matter. According to the request, Pennichuck Water Works, Inc. (PWW), the Office of Consumer Advocate (OCA), and Staff agreed that PWW should file its quarterly update concerning its 2018 budgeted capital projects on August 15, 2018 rather than July 15, 2018. The parties also agreed that the procedural schedule should be amended so that Staff and the OCA's recommendations would include consideration of PWW's August 15 quarterly update filing. Therefore, PWW, the OCA, and Staff request that the OCA and Staff file their respective recommendations on PWW's QCPAC on August 29, 2018 rather than August 8, 2018.

The Commission has determined that the modification to the schedule is in the public interest and therefore has approved it. Accordingly, recommendations on PWW's QCPAC are due August 29, 2018.
