On March 7, 2018, Empire Telecommunications and Energy Consultants, LLC d/b/a Empire Energy (Empire Energy) submitted an application with the Commission to renew its registration as a provider of electric aggregation service.

Commission Staff filed a memorandum on May 29, 2018 notifying the Commission that Empire Energy's registration lapsed on May 4, 2018, and recommending that, because information required to complete the application was not provided within 60 days of Staff's request for that information, approval of Empire Energy's registration renewal application be denied, pursuant to N.H. Code Admin. Rules Puc 2003.06(e)(2), and that this docket be closed.

Empire Energy's application for registration renewal has been denied, pursuant to Puc 2003.06(e)(2), and Empire Energy's registration as an electric load aggregator has lapsed.
