The above-referenced Orders approve changes to distribution, transmission, and stranded cost rates, effective June 1, 2018. The total bill impact to customers using 650 kilowatt-hours per month is an increase of \$7.00, or 5.80%.

The Company is also submitting housekeeping changes to tariff pages 49, 51, and 55, which include a change to the email address by which customers may contact the Company for interconnections.

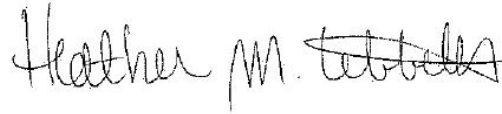
