Revised Procedural Schedule

To the Parties:

On December 12, 2019, Liberty Utilities (Granite State Electric) Corp. d/b/a Liberty Utilities (Liberty) filed a request to amend the current procedural schedule by extending the December 6 deadline for filing responses to discovery to December 13, 2019. Liberty stated that it did not receive timely notice of Commission Staff's (Staff) discovery requests, because the responsible Liberty employees were not included on the discovery service list. Therefore, Liberty requires more time to respond to these requests. Liberty represented that Public Service Company of New Hampshire d/b/a Eversource Energy and Staff assented to its request, and that no other party objected.

The Commission has determined that the standard for an extension of time contained in N.H. Admin. R., Puc 202.04 has been satisfied. Accordingly, the deadline for filing responses to discovery is extended until 4:30 p.m. today, December 13, 2019.
