Re: DT 18-070, 2018 Intrastate Access Rate Tariff Filings by Registered Telephone Utilities

To Registered Telephone Utilities:

On June 5, 2018, by secretarial letter issued in the above-referenced docket, and in compliance with the Federal Communications Commission (FCC) Report and Order and Further Notice of Proposed Rulemaking regarding the Universal Service Fund and Inter-Carrier Compensation in WC Docket Nos. 10-90, et al., FCC Release No 11-161, issued on November 18, 2011 (the Transformation Order), tariff filings made by registered telephone utilities that are not incumbent local exchange carriers (ILECs) generally go into effect on July 31, 2018, as ordered by the FCC.

On July 24, 2018, Staff recommended that the Commission allow the following tariff filings to take effect on the dates specified below:

- ACN Communication Services LLC, effective August 2, 2018
- Bandwidth.com CLEC, LLC, effective August 2, 2018
- Birch Communications of the Northeast LLC, d/b/a Birch Communications, effective August 2, 2018
- Bullseye Telecom, Inc., effective August 2, 2018
- CRC Communications LLC (Otelco), effective July 31, 2018
- IDT America Corp., effective August 2, 2018
- Level 3 Communications LLC (CenturyLink), effective July 31, 2018
- Paetec Communications, Inc., effective August 2, 2018
- Verizon Access Transmission Services, effective July 31, 2018
- Wide Voice LLC, effective August 2, 2018

The Commission has reviewed and approved Staff's recommendation. Accordingly, the intrastate access tariff revisions filed by the aforementioned registered telephone utilities shall be effective on the dates specified above.
