Dear Director Howland:

Enclosed please find an original and six copies of Pennichuck East Utility, Inc.'s ("PEU") revised special contract with Pillsbury Realty Development, LLC ("Pillsbury") regarding Pillsbury's Woodmont Commons development in the Town of Londonderry. The special contract allocates between PEU and Pillsbury the costs of constructing a 1.1 million-gallon water storage tank.

PEU filed revised tariffs in Docket No. DW 18-189 to address changes in the taxability of Contributions in Aid of Construction ("CIAC") that resulted from the 2017 Tax Cuts and Jobs Act. As a result of the change in tax law, receipt of CIAC on or after January 1, 2018 is now a taxable event. This change affects the special contract in this proceeding by adding the unanticipated cost of the CIAC tax.

PEU and Pillsbury have resolved the CIAC tax issue as to Woodmont Commons. That resolution is manifested in revisions to Section 4 of the special contract. In support of the revised special contract and to explain why the deviation from PEU's general rate schedules remains warranted, PEU is providing the testimony of Larry D. Goodhue, PEU's Chief Executive Officer and Chief Financial Officer. The revised special contract is attached to Mr. Goodhue's testimony, as is a letter of support from Pillsbury. PEU requests the Commission approve the attached revised special contract for the reasons stated in the petition and supporting testimonies.
