On January 3, 2018, the Commission ordered Forest Edge Water Company. and all other regulated utilities to take specific accounting actions with regard to and to file a proposal with the Commission to address the effects of Federal and State tax law changes that occurred at the end of 2017. *See Investigation to Determine Rate Effects of Federal and State Corporate Tax Reductions,* Order No. 26,096 (January 3, 2018). On July 30, 2018, Forest Edge petitioned for exemption from these requirements. Forest Edge's petition demonstrated that the tax changes would have no impact on the company. On August 24, Commission Staff recommended that the Commission approve the company's request for exemption from Commission Order No. 26,096 and any further participation in Docket No. IR 18-001.
