PETITION TO EXTEND THE SPECIAL CONTRACT
TO PROVIDE EMERGENCY BULK WATER SERVICE

PRE-FILED SUPPLEMENTAL TESTIMONY OF HAROLD MORSE

Q. Please state your name, address and position with Hampstead Area Water Company, Inc.

A. My name is Harold Morse, of 54 Sawyer Avenue, Atkinson, NH and I am the President of Hampstead Area Water Company, Inc., (HAWC).

Q. Describe the overall history of HAWC?

A. HAWC is presently franchised in most areas of Hampstead and Atkinson, New Hampshire, and has franchised satellite systems in various towns in Rockingham and Strafford Counties as per the Schedule A attached to the Petition.

Q. Did you file a petition to expand HAWC's franchise to include the Tisdale Trailer Park?

A. Yes, that petition is before the Commission, docket DW 19-011. The procedural schedule in that petition is such that the matter will not be before the Commission until at least May 31, 2019.

Q. Why are you requesting to extend again the special contract to provide emergency water service in Salem, New Hampshire?

A. The Commission approved our petition to provide water service to the Tisdale Trailer Park on an emergency basis, order no. 26,174 (the Order), until November 1, 2018, and extended that deadline to April 30, 2019 on November 20, 2018, but the procedural schedule for docket DW

1 19-011 will extend beyond the current April 30, 2019 deadline. Since DW 19-011 is now filed
2 and a procedural schedule has been established, this petition requests that the deadline in this
3 docket be extended until an order is issued by the Commission for docket DW 19-011.

4 Q. Can you describe the agreement that the Company has made with the owner?

5 A. HAWC has agreed to continue to supply bulk water service to Tisdale from its system at
6 Lancaster Farm over a 2" metered water main line to the existing trailer park system and install a
7 meter at that point. We will continue to supply water to that system for distribution to the
8 residents.

9 Q. What is the present tariff charged by the Company for a 2" metered water main line?

10 A. The tariff for HAWC is a consolidated rate of \$100.00 base charge per month with a
11 consumption charge of \$6.11 per 100 cubic feet of water consumed.

12 Q. Are you requesting that the bulk rate continue until the Commission decides the petition to
13 extend the Company's Franchise Area to include Tisdale Trailer Park?

14 A. Yes.

15 Q. Where does the rate for HAWC come from?

16 A. The rate was established under DW-17-118 by Order number 26,165.

17 Q. Does this conclude your testimony?
