On November 1, 2018, EnerConnex, LLC (EnerConnex) submitted an application with the Commission to register as a provider of natural gas aggregation service.

Commission Staff filed a memorandum on November 6, 2018, in which it confirmed its review of the application and its conclusion that the application meets the requirements for registration under N.H. Code Admin. Rules Puc 3000. Staff recommended that EnerConnex's registration application be approved for a two-year term.

The Commission has approved Staff's recommendation. Accordingly, EnerConnex's application for registration is approved, effective as of November 7, 2018. The registration is for a term of two years, and expires at the close of business on November 7, 2020. Pursuant to Puc 3003.05(a), you must submit a renewal application at least 60 days prior to the expiration of the approved registration term, on or before September 8, 2020.

Please be aware that registered providers of natural gas aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 3000 – Competitive Natural Gas Supplier and Aggregator Rules. These rules are available at: <u>http://www.puc.nh.gov/Regulatory/Rules/PUC3000.pdf</u>.

Please note that each registered natural gas aggregator is subject to an annual assessment of \$2,000, unless it demonstrates that its gross revenue in New Hampshire during the preceding fiscal year (from July 1 through June 30) was less than \$10,000, pursuant to RSA 363-A:2, III and 5.
