2018 Alternative Compliance Payment Past Due

Dear Mr. Sandford:

Pursuant to RSA 362-F:8, and N.H. Code Admin. Rules Puc 2503.03(a), competitive electric power suppliers (CEPS) such as Agera Energy, LLC (Agera) are required to file a Form E-2500 *Annual Renewable Portfolio Standard Compliance Filing*. Form E-2500 filings for the 2018 compliance year were due on or before July 1, 2019. The Commission received Agera's signed Form E-2500 on July 9, 2019. Agera's 2018 filing shows that it owes alternative compliance payments (ACPs); however, no payments have been made to date. Under RSA 362-F:10, II and Puc 2503.03(b), payment of all ACPs was due on or before July 1, 2019.

In order to come into compliance with New Hampshire requirements for CEPS, Agera must pay the full ACP amount due within ten (10) days following the date of this letter, i.e. on or before September 27, 2019. Payment may be made by check payable to the State of New Hampshire or through electronic transfer to the Renewable Energy Fund bank account. Please contact Juli Pelletier, PUC Business Administrator, at (603) 271-6008, or at Juli.Pelletier@puc.nh.gov, for additional information regarding payment arrangements.

If full payment is not received by September 27, 2019, the Commission may pursue further actions to enforce the ACP payment obligation, which may include issuance of a Commission order requiring payment, demand against the financial security provided by Agera, pursuant to Puc 2005.06(c), and/or referral of the unpaid amount for collection to the New Hampshire Department of Justice.
