In compliance with the Commission's Order No. 26,215 in Docket No. DE 18-182 (Order Approving Adjustment to Stranded Cost Recovery Charge) and the secretarial letter issued on January 24, 2019 in Docket No. DE 17-171 (Approval of Late Payment Charge Tariff Amendment), the following tariff pages are transmitted herewith:

These tariff pages implement a decrease in the Company's stranded cost recovery charges and reinstate the late payment charge as approved by the Commission in the Order and secretarial letter referenced above.

The Commission also approved an increase in the Company's Default Energy Service Rate DE effective February 1, 2019 in its Order No. 26,203 in Docket No. DE 18-002. Revised tariff pages were filed with the Commission in compliance with this Order on January 7, 2019.

For customers receiving delivery service only from Eversource, the impact of the stranded cost recovery charge change is a 6.3% decrease in the overall average retail rate. For customers receiving both delivery

service and energy service from Eversource, the combined impact of the stranded cost recovery charge and default energy service changes is a 4.8% increase in the overall average retail rate.

Black-lined tariff pages denoting the stranded cost recovery charge changes effective February 1, 2019 have been submitted for easy identification of the changes.

Black-lined tariff pages associated with the late payment charge were filed with the Commission on December 13, 2018 in Docket No. DE 17-171. In this filing, the authorization footnote has been added to the tariff pages in compliance with the Commission's rules.

Supplemental Information on the Filing

The enclosed "Summary of Rates" reports summarize all the rates and charges in the Company's tariff by month, rate class and rate component. In addition, we have enclosed a schedule of "Typical Bill Comparisons" based on the rates in effect on January 1, 2019 and the new rates. The monthly bill amount (including default energy service) for a residential customer served under Rate R and using 600 kilowatt-hours, previously \$122.16, will decrease to \$121.58 on February 1, 2019, a decrease of \$0.58 or -0.5%.
