Dear Mr. Meehan:

On December 20, 2018, Northern New England Telephone Operations LLC d/b/a Consolidated Communications-NNE ("CCI") filed a request for approval of an amendment to the Interconnection Agreement between CCI and Charter Fiberlink NH-CCO LLC, under Section 252(e) of the Telecommunications Act of 1996. The amendment is to an agreement between Verizon and C & W Communications, LLC, the adoption of which was considered in Docket No. DT 08-043 and effective by operation of law on or about June 16, 2008.

Commission Staff filed a memorandum on January 10, 2019, recommending that the amendment to the interconnection agreement be allowed to go into effect by operation of law, 90 days after the date of the original filing.

The Commission has reviewed and approved Staff's recommendation. Accordingly, the amendment to the interconnection agreement shall be effective March 20, 2019.
