Dear Mr. Trefethen:

On January 3, 2019, Summerview Energy, LLC (Summerview Energy) submitted an application with the Commission to renew its registration as a provider of electric aggregation service.

Commission Staff filed a memorandum on January 3, 2019, in which it confirmed its review of the application and its conclusion that the application is complete. Staff recommended that Summerview Energy's registration renewal application be approved for a two-year term, beginning on March 26, 2019, pursuant to Puc 2003.06(e)(1).

Your application for registration renewal is approved effective as of March 26, 2019, under Puc 2003.06(e)(1). The renewed registration is for a term of two years and expires at the close of business on March 26, 2021. Pursuant to Puc 2003.06(a), you must submit your next renewal application at least 60 days prior to the expiration of the approved registration term, on or before January 25, 2021.

Please be aware that registered providers of electric aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 2000 – Competitive Electric Power Supplier and Aggregator Rules. These rules are available at:
<http://www.puc.nh.gov/Regulatory/Rules/PUC2000.pdf>.

Please note that each registered electric aggregator is subject to an annual assessment of \$2,000, unless it demonstrates that its gross revenue in New Hampshire during the preceding fiscal year (from July 1 through June 30) was less than \$10,000, pursuant to RSA 363-A:2, III and 5.
