Staff has reviewed the filing received on January 17, 2020, in the above-captioned proceeding, and confirms compliance with Puc 1603 filing requirements. Staff notes, however, that the authorizing order and docket number were omitted off the footer of all filed pages. Puc 1603.06 (o) states:
