Dear Ms. Howland:

On March 27, 2019, representatives of Consolidated Communications of Northern New England Company, LLC d/b/a Consolidated Communications-NNE (Consolidated), Charter Fiberlink NH-CCO, LLC and Time Warner Cable Information Services (New Hampshire), LLC (collectively, Charter), the CLEC Association of Northern New England, Inc., which includes CRC Communications LLC d/b/a OTELCO, FirstLight Fiber, and Biddeford Internet Corp. d/b/a Great Works Internet (collectively, CANNE), and Commission Staff met in technical session to discuss preliminary issues relevant to this proceeding, including regional cooperation with representatives of other state regulatory bodies and the development of an initial procedural schedule for the docket.

The technical session participants agreed to an initial procedural schedule to include questions submitted to Consolidated for response and the scheduling of a conference call, to include representatives of Maine and Vermont regulatory bodies, for Thursday, April 4, 2019, to begin at 10:00 a.m.
