To the Parties:

By secretarial letter dated June 28, 2019, the Commission approved the parties' proposed procedural schedule, which provided for settlement conferences on March 24 and 25, and hearings on April 14-16, and 22-23, 2020. On March 19, 2020, Commission Staff (Staff) filed a letter requesting the Commission to cancel the March 24 and 25 events in response to the current COVID-19 pandemic. Staff requested the Commission to reserve the presently scheduled April 2020 dates for technical sessions and settlement conferences in the above-captioned matter.
