Dear Chairman Goldner:

In a Procedural Order in this matter dated June 23, 2023, the Commission stated:

We note that the DOE has shared Eversource's May 31 filing with the outside auditor, River Consulting Group, Inc. (RCG), and indicated that if a further final BPA Report is produced incorporating Eversource's feedback, the DOE will file such report with the Commission. The BPA Report will be deemed the final version of the report, unless a further report is filed by the DOE containing revisions by RCG, which shall then be considered the final report.

RCG has produced the "further final BPA report" referred to above (it is dated July 2023) and that report (which the Commission stated "shall then be considered the final report") is included letter for filing in this matter. Now that all the requirements concerning the BPA from the original rate case settlement and the subsequent Commission orders have been satisfied, the Department considers this matter to be closed.

Consistent with the Commission's current practices this letter is being filed only in electronic form.
