Procedural Order Re: Motion for Extension of Time

On May 24, 2023, Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource) filed a motion to extend a deadline established in Order No. 26,804 (April 24, 2023) for filing “a motion for confidential treatment accompanied by the full business process audit report in redacted and confidential forms, as well as any written comments on the business process audit report,” which deadline also expired May 24. Eversource represented that the parties filing responses to the underlying “Motion to Resolve Dispute Regarding Settlement Agreement Implementation,” the New Hampshire Department of Energy and the Office of the Consumer Advocate, assented to the deadline extension. Eversource’s motion is GRANTED, so that Eversource shall submit this filing on or before May 31, 2023.
