Dear Chairwoman Martin:

On July 1, 2021, the Commission issued Order No. 26,494 which denied the Company's request to implement that part of the step increase related to the battery storage program, stating the following:

Third, we requested additional information related to the Battery Pilot Program during the hearing (Exh. 80 has been reserved for the response). For purposes of this step adjustment, we exclude the Battery Pilot Program investment adjustment until the requested information has been received and reviewed,¹ and will consider recovery in a future rate case.

¹ Note that Commission stated at hearing that the information to be provided in Exhibit 80 was not necessary to determine the prudence of the battery-related costs at issue:

[Sheehan] I think that that information may not affect this particular case, the resolution of it. So I wonder if the Commission is looking for it prior to order, or whether if it comes in sometime after that would be acceptable.

The Company filed Exhibit 80 on July 15, 2021.

On August 29, 2021, the Commission issued Order No. 26,512 which, *inter alia*, found Exhibit 80 to be insufficient and established the following process for consideration of those costs:

Therefore, we will review the 2020 battery pilot investment to determine whether it was prudent, used, and useful and should be included in rate base, and the appropriateness of a rate adjustment, following receipt of a conforming Exhibit 80.

Order 26,512 at 8. The Company filed a conforming version of the exhibit, titled Exhibit 80A, on September 16, 2021.

Given this filing, and given that all relevant evidence related to prudence was examined at the June 24, 2021, hearing, the Company respectfully asks the Commission to approve recovery of the battery pilot investments, to be included in rates as of November 1, 2021.
