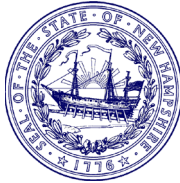

Dear Mr. Hall:

It has come to the attention of the Public Utilities Commission (PUC or the Commission) that tariff Original Page 36A posted to the PUC web site is incorrect in the above-captioned proceeding. The Original Page 36A was correctly filed in DE 16-576 and posted.

Since that time, Liberty filed a complete tariff NHPUC No. 21 in this docket on July 13, 2020. At that time, the prior version of Original Page 36A was filed. Due to oversight, the Commission did not note that Page 36A did not contain the same language as the Original Page 36A filed in docket DE 16-576.

On July 6, 2022, Liberty emailed the complete NHPUC No. 21 with the correct Original Page 36A to the Clerk's Office and to the Department of Energy but not to the service list. The Commission requests that Liberty file the corrected Original Page 36A only to the service list for DE 19-064.

In accordance with the Secretarial letter issued March 17, 2020, this letter will be filed electronically only at this time.
