Dear Mr. Richards,

On March 29, 2019, Albireo Energy, LLC (Albireo Energy) submitted an application with the Commission to register as a provider of electric aggregation service.

Commission Staff filed a memorandum on April 3, 2019, in which it confirmed its review of the application and its conclusion that the application meets the requirements for registration under N.H. Code Admin. Rules Puc 2000. Staff recommended that Albireo Energy's registration application be approved for a two-year term.

Your application for registration is approved effective as of April 3, 2019, under Puc 2003.05(g)(1). The registration is for a term of two years and expires at the close of business on April 3, 2021. Pursuant to Puc 2003.06(a), you must submit your renewal application at least 60 days prior to the expiration of the approved registration term, on or before February 2, 2021.

Please be aware that registered providers of electric aggregation service are subject to specific requirements contained in N.H. Code Admin. Rules Puc 2000 – Competitive Electric Power Supplier and Aggregator Rules. These rules are available at: <http://www.puc.nh.gov/Regulatory/Rules/PUC2000.pdf>.

Please note that, effective as of July 1, 2014, each registered electric load aggregator is subject to an annual assessment of \$2,000, unless it demonstrates that its gross revenue in New Hampshire during the preceding fiscal year (from July 1 through June 30) was less than \$10,000, pursuant to RSA 363-A:2, III and 5.
