Dear Ms. Howland:

On June 3, 2019, Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource) filed testimony and exhibits in support of a reconciliation of revenues and expenses for its Default Energy Service Rate and Stranded Cost Recovery Charge for 2018. The Commission held a pre-hearing conference in this matter on September 30, 2020, which was followed by a technical session where Eversource, Staff and the Office of the Consumer Advocate reviewed Eversource's filing and Eversource's responses to data requests Staff issued in July.

Staff asked Eversource several questions at the technical session that required additional review before answering. Eversource provided answers to these questions on October 7 and the participants agreed to meet in a second technical session on October 13 to examine Eversource's responses and to develop a proposed procedural schedule for the remainder of this case, which will allow for a comprehensive settlement if all issues can be resolved.

Therefore, on behalf of Eversource and the OCA, Staff respectfully requests that the Commission schedule a second technical session in this matter on October 13, 2020, beginning at 10 am. Staff projects that the session will last about 2 hours.
