Pursuant to the approved procedural schedule in the above-mentioned docket, a technical session/settlement conference was held on March 9, 2020. Four participants attended: Pennichuck Water Works, Inc. (PWW); the City of Nashua; the Office of the Consumer Advocate (OCA); and the Staff of the New Hampshire Public Utilities Commission (Staff).

After discussion, PWW, the OCA, and Staff agreed that another technical session would be beneficial in hopes of attaining a settlement agreement. The City of Nashua did not join in the discussion as it left early due to a prior commitment.

For that reason, PWW, the OCA, and Staff agreed to the following addition to the procedural schedule:

Technical Session


April 3, 2020 @ 9 a.m.
