On May 14, 2019, Teleport Communications of America LLC (TCAL) filed a safety valve request to overturn the denial by Somos of its request for a specific block of numbers in the Dover rate center. TCAL states that it has a customer looking for a specific series of 5-digit numbers that will allow it to easily integrate the numbers requested into an existing network configuration. TCAL supported its assertion with a letter of intent and explanation from the customer.

The Dover exchange has appropriate, unassigned thousand-number blocks that would meet TCAL’s needs. Staff recommends that the Commission grant TCAL’s request for a waiver.
