On October 22, 2020, the Commission held an evidentiary hearing for the above-mentioned matter, which four parties attended: Omni Mount Washington Hotel, LLC (Omni); Abenaki Water Company, Inc. (Abenaki or the Company); Bretton Woods Property Owners Association; and Commission Staff (Staff) (collectively, the Parties). During the hearing, Commissioner Bailey made a record request, directing the Parties to submit any Commission-approved special contracts between Omni and Abenaki. The Commission held Exhibits 34 through 37 open to allow for each respective party to make a submission.
